FAST FACTS: USEF Para-Dressage Selection Trials Begins for the 2010 Alltech FEI World Equestrian Games™

Wayne, IL-June 25, 2010-The United States Equestrian Federation (USEF) Selection Trials has begun for the 2010 Alltech FEI World Equestrian Games™ at the beautiful Lamplight Equestrian Center in Wayne, IL. Thursday's evening event featured the Para-Dressage horse jog of each Para-Dressage horse competing this weekend while being judged by top international judges. Coaches, riders, judges, officials, and spectators are on hand to watch each horse jog down the lane in front of the Para-Dressage Arena.

Fifteen Para-Equestrian athletes have scores that will allow them to compete in the Selection Trials. Out of those 15, ten of the riders will be selected to compete in the Para-Dressage team. Out of the ten riders, four will make the team, and six will ride as individual riders.
